## Fairground Development & Planning

### URBAN AGRICULTURE CENTRE (UAC)

The Grand Opening of BADAS' Urban Agriculture Centre (UAC) was held during the new 'Spring Kickoff' event on May 17<sup>th</sup>. To refresh your memory, the UAC includes a 24' x 24' passive solar greenhouse with tool library; a food forest windbreak with over 200 trees, shrubs, and flowers; and space in which to host various activities and smaller events.

Beaumont Men's Shed Association stepped up to complete the interior of the passive solar greenhouse, which now has shelves for storage and a work bench to repair equipment. 2026 will see this building used daily as a gathering and communication hub, in support of programs, plant sales, and gardeners. In March 2026, we will begin growing in the garden boxes inside and will start seedlings for our plant sale fundraiser.



Hopes were high for renting the UAC and large tent for summer events, but a major windstorm reaching 130 kph destroyed the tent. We are grateful to Clearwater Valley Pony Club for lending us their tent to use for summer camps and seniors' programs.

The UAC piloted our first ever summer camp – 'Flittermice and Dumbledores' Nature Camp. 11 youth signed up and it was a huge success. The kids aged 5-8 walked away with a ton of knowledge about bats, bees, and native plants. A huge thank you to Deni Cameron who championed this program and designed most of the educational materials.

In 2026 we hope to continue with rentals and summer camps, and to introduce school programs. However, these plans depend on receiving the Canada Summer jobs grant to support staffing needs.

## Finance Committee & Finances

The Finance Committee oversees budgeting, grant applications, and reviews financial activity for BADAS. A financial report with draft FY2026 budget is presented on page 5.

**REVENUE:** Operating income for BADAS varied greatly over the years, depending on events, grants, and Casino income. Last fiscal (2025), BADAS recorded higher revenue than the previous 8-year average. Main sources of revenue were:

- AB Agriculture & Irrigation program grant – \$24,858.
- Facility fees – \$18,792, close to the prior 5-year mean.
- Leduc County & Beaumont operating grants – \$16,000.
- Special Events – \$29,760, well above prior 5-year mean.
- Sponsorships/Donations – \$3,280, lower than normal.
- Varied – \$6,813, memberships, gaming, reimbursed exp.
- Special municipal, government, & other grants – \$50,500

**EXPENSES:** Operating costs (\$124,060) vary less than income but were 59% higher in FY 2025 than the prior 5-year average. Payroll and contract staff expenses accounted for 42% of the total. Land improvements, Fairground operations, fundraiser expenses, accounting fees, insurance premiums, office/website costs, and volunteer expenses raised the proportion to 96% of total operating expenditures (see page 5).

Capital expenditures in FY 2025 totaled \$4,882, most of which (69%) was spent on the garden irrigation system.

## Operations Committee

Operations Manager Dennis Madu performed most of the maintenance and grounds-keeping work. Supplies and services were monitored and ordered, garbage and manure were cleaned up, grass and weeds were mowed and trimmed, equipment was repaired and serviced, and structures were maintained. Thank you to all volunteers that helped keep the Fairground in fine shape.

Thank you to Dennis Madu for serving as Operations Manager for 8 years at the BADAS Fairground. Prior to 2018, Dennis performed the same work at the Fairground but as a volunteer.

We are actively seeking a new Facility/Operations Manager to manage our grounds next year and beyond. This is a paid position starting at \$22/hour.

## Equine Committee

### FACILITY BOOKINGS

Equine use of the Fairground creates the most bookings, user numbers, and rental/fee revenue. Numbers were much lower than in previous years (see chart). Total number of bookings in 2025 was **66**, 13% less than in 2024. 12 were cancelled. Logged user-days for 2025 was **353**, 48% lower than in 2024. Several factors contributed to the lower numbers in 2025:

- Beaumont Horse Trials (BHT), which usually accounts for 240 to over 300 user-days, was not held in 2025 due to circumstances beyond the BHT Association's control. BHT will return bigger and better than ever in 2026.
- Regularly booked lessons for Clearwater Valley Pony Club (CVPC) members were discontinued after 2023. These accounted for 50-150 user-days in past years.

- Cross-country clinics and other equine events booked often prior to COVID have been booked rarely since.

Cancellation numbers were the same as in 2024 (18% of total bookings). For the first time ever, bookings were evenly spread amongst May, June, July, and August, although cancellations were much higher in July and August. Bookings really diminished in September, despite the great fall weather.

Two major equine events (*Staden-Donnelly X-C Clinic* and *Alberta North Region Pony Club Rally Camp*) were held in 2025.

## Policies & Procedures Committee

The Policies & Procedures Committee worked on several policies and procedures in FY 2025. Existing documents were revised and updated: Leadership Funding Request form and grants for youth leadership, Abusive Patrons Policy, GPCG Policies and Procedures, and the Equine Facility Users Policy.

The following new policies were created: Code of Conduct for Directors, Code of Conduct for Employees, Code of Conduct for Members, Disciplinary Actions for Code of Conduct Violations, and Winter Recreation Policy.

## Community Engagement Committee

The Community Engagement Committee is responsible for membership, social media, and the BADAS website.

BADAS attended the Beaumont Alberta Farmers Market throughout the summer.

**BADAS Membership** – 105 Full (adult), 8 Junior (12-17 years old), 18 Senior, and 21 Lifetime – totalled 152 in 2025. Our long-term average individual membership (2004-2025) is 154.

## YOUTH COMMITTEE

BADAS was awarded a Canada Post Community Foundation grant of \$16,000 to pilot a youth committee to build our connection with youth. A coordinator was hired to develop this project. A further aim is to develop a small farm entrepreneur program that will enable youth to earn money while learning business, marketing, and farming skills. Our goal is to become a known resource for youth to gain work experience by volunteering at our events, and by participating in the youth committee and the farm entrepreneur program.

## OTHER BADAS DEVELOPMENT PROJECTS

BADAS is proud to announce 2 major new development projects aimed to increase revenues and better utilize our land. In addition, 2 long-term projects continue.

**RV Campground** – A new RV Campground, with about 30 camping sites, will hopefully be developed just north of the current stables. More details will be available at the AGM.

**Project Forest** – is a reforestation project of 9 acres that will become an AMA Centennial Forest with an all-season recreational trail including cross-country skiing. Cross-country skiing is expected to begin soon with the arrival of our new grooming equipment. We hope this activity will help us build our membership and raise awareness about our Fairground.

**Gobeil Heritage Barn (GHB)** – No additional funds were obtained in FY 2024 to further develop the GBH in 2025. Plans are being formed for obtaining funding to complete development of this facility.

**Magnan Heritage House (MHH)** – In FY 2025 the furnace was purchased, and the sill plate was sealed and insulated. Installation of the furnace, pump out tank, and fencing remain for this structure to become the HQ for BADAS.

## POSSIBLE SALE OF FAIRGROUND LAND

Pressures of development and the need to grow to become sustainable have encouraged BADAS to look at the sale of about 35 acres of land. This is an important time for BADAS members and the community to become active in the future of BADAS. We will be launching an awareness campaign to keep our region informed about the potential sale of the land. The Board is carefully considering how the sale could influence ways we can develop to meet our mandate, vision, and mission. We encourage anyone who is interested in the future of BADAS to get their membership and watch for information sessions and engagement about the land sale. Members have the deciding vote. ## Events Committee

This is a new standing committee struck by the BADAS Board of Directors in 2025. The purpose of this committee is to plan and organize annual community events, engage with community groups interested in partnering for events, work with the Fundraising team to obtain sponsors, work with the Community Engagement team to promote BADAS, and to develop systems for event feedback and reporting.

We are looking for Ag Society members to take on organizing these events as members of the Events Committee. A few long-term members that have organized these events in the past are still available to help. It is important to develop 'new blood' with the help of this existing expertise. Since Events and Fundraising are so closely linked, it will be important for these 2 committees to work closely together.

Following is a synopsis of events that were held during 2025, including some new ones – Spring Kickoff, Seniors Connect, and the BADAS Curling Bonspiel (officially a FY 2026 event).

### SPRING KICKOFF

Spring Kickoff was hosted on May 17 in partnership with Beaumont Library to help promote the seed library and to fundraise with plant sales. BADAS also partnered with the Beaumont Knights of Columbus, who BBQed burgers and hot dogs, and sold other refreshments as a joint fundraiser. Thank you, Greenhaven Gardens, for your sponsorship.

### BEAUMONT DAYS PARADE

The Beaumont Days Parade, hosted by BADAS in conjunction with the Town/City of Beaumont since the mid-1990s, was held on Saturday May 24<sup>th</sup>. The registered lineup numbered 40, but that included 4 dignitaries riding on or walking with 4 other entries, the lead RCMP vehicle, and the Beaumont Street Sweeper (followed the horses). One entry pulled out at the last minute due to lack of planning and preparation.

BADAS entered a float in 2025 (see picture below). Many thanks to Flaman Rentals for providing a trailer for our float entry, and a flat-deck trailer as the stage at RRF '25, August 23.



### OPEN FARM DAYS (OFD)

OFD was hosted at the Fairground on Saturday, August 16. 127 people attended. This event included both self guided and guided garden tours, a BBQ fundraiser, plant sale, farm equipment display, lawn games, and kids' crafts. A huge thank you to Leduc Co-op and ReEarth for sponsoring this event. Once again BADAS partnered with Beaumont Knights of Columbus on the BBQ fundraiser.

## RURAL ROOTS FAIR (RRF)

The 8th annual RRF, held August 23, drew 1,418 visitors, exactly 100 less than in 2024. The one-day format adopted in 2023 remained successful in 2025. This year we featured live music from local artists, conservation group presentations, caricature artists, mascots familiar to kids, a petting zoo, nature crafts, farmers market, lawn games, dunk tank auction, and a community mural on the new greenhouse!

As at past RRF events, we partnered with the Artists' Association of Beaumont, Beaumont Knights of Columbus, and Beaumont Alberta Farmers Market.



### SENIORS CONNECT

Thanks to a Seniors grant from a Leduc County, we were able to build relationships with the seniors' community. We hosted a yoga class and wild bird information session as well as a Seedy Sunday event in partnership with the Beaumont Library. Remaining funds will be used to partner with local seniors to showcase their talent in the production of a murder mystery March 7, 2026.

### VOLUNTEER APPRECIATION BBQ

Sometimes also called 'Harvest Fest', this event not only signified the end of gardening for the year (with a garden cleanup work-bee) but was hosted by BADAS to show appreciation to all members that volunteered for various events through the year. It was held at the Fairground the first weekend in October.

### BEAUMONT CURLING BONSPIEL

A new event, the Beaumont Curling Bonspiel, was launched late in FY 2025. Some registrations were received in FY 2025, but the event was held in the current FY, 2026. And it turned out to be very successful. Expect more information next year. ■
